

Fund Update for the Generate KiwiSaver Scheme:  
Moderate Fund

30 June 2025

This fund update was first made publicly available on 28 July 2025.

What is the purpose of this update?

This document tells you how the Moderate Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Generate Investment Management Ltd prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Before 16 May 2022, the fund was called the Conservative Fund. On 16 May 2022, the fund was renamed the Moderate Fund.

Description of this fund

The Moderate Fund aims to provide a modest to medium return over the short to medium term. It invests in an actively managed portfolio made up of slightly more income assets than growth assets. Volatility is likely to be medium to high. Returns will vary and may be low or negative at times.

What are the risks of investing?

Risk indicator for the Moderate Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund’s assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way. Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

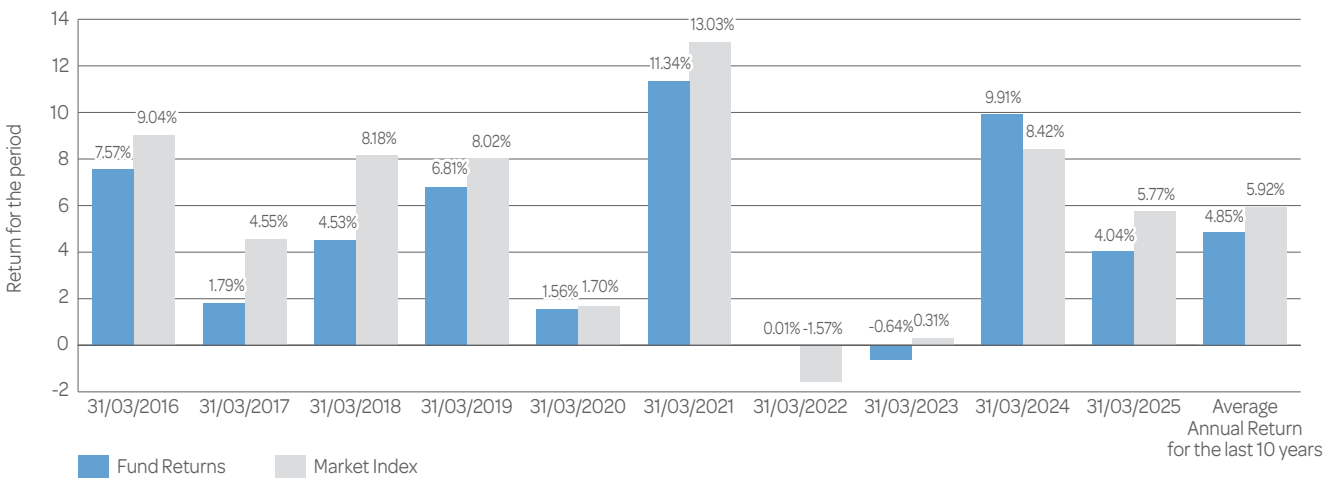

How has the fund performed?

The market index return reflects a composite of benchmark index returns, weighted for the fund’s target asset allocation, being the fund’s relevant benchmark since inception. All of the share market benchmark indices used include dividends but do not include imputation credits. Annual return graph



This shows the return after fund charges and tax for each of the 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 30 June 2025.

**Important:** This does not tell you how the fund will perform in the future. Returns in this graph are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower. Benchmark returns in the graph are before the deduction of tax.

What fees are investors charged?

A portion of the ‘other management and administration charges’ relate to management, performance and administration charges from investments in underlying funds. Some of these calculations are based on estimates.

Investors are not currently charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the PDS for more information about fees.

Small differences in fees and charges can have a big impact on your investment over the long term.

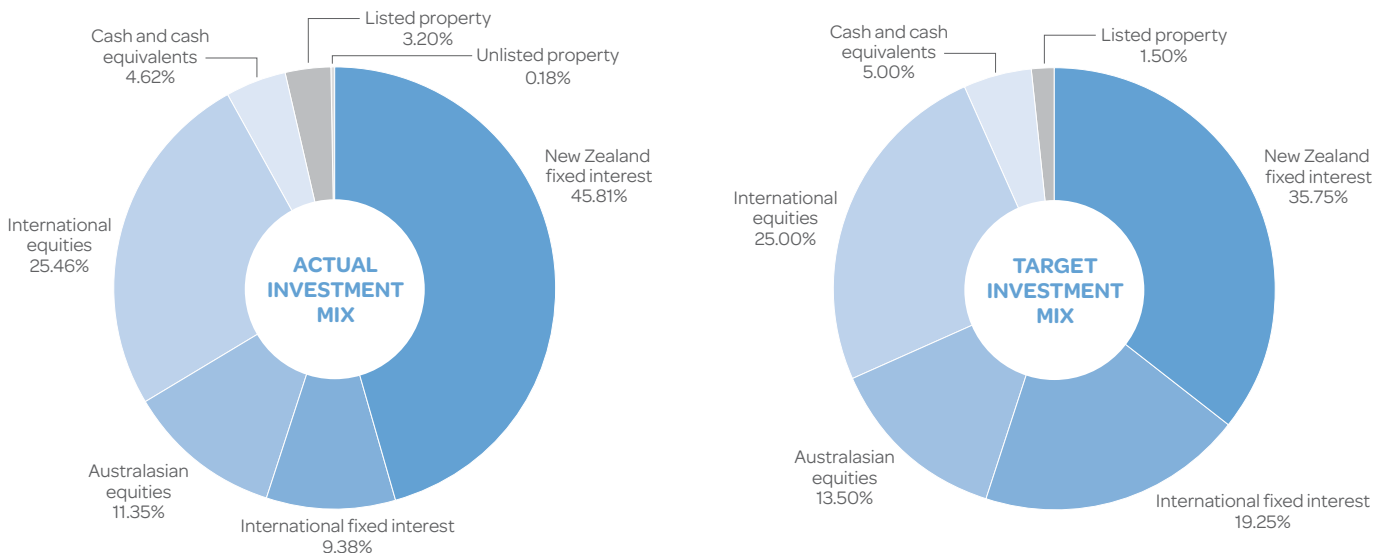
Example of how this applies to an investor

Hannah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hannah received a return after fund charges were deducted of \$788 (that is 7.88% of her initial \$10,000). Hannah also paid \$36 in other charges. This gives Hannah a total return after tax of \$752 for the year.

The fund’s net foreign currency exposure was 13.04% of net asset value on the 30 June 2025. At target the fund’s net foreign currency exposure is 12.50% of net asset value. ### Notes

1. As the fund's investment policy has changed significantly and its returns before the change would not reflect its current investment policy, with the effect from 20 May 2022, a combination of market index returns and the fund's actual returns has been used to complete the risk indicator. Actual returns have been used from 20 May 2022 to the end of the period to which this fund update relates. For all relevant periods prior to 20 May 2022 market index returns have been used in order to construct a total 5 years of returns on which to base the risk indicator. As a result the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
2. This fund invests in underlying funds managed by third party managers. The fees on these funds are taken from offer documents or estimated using data from their most recent financial statements. Where applicable, performance fees on underlying funds are estimated taking into account highwater marks.
3. Membership fees are the monthly fixed dollar charges for membership in the Generate KiwiSaver Scheme. You will pay only \$3 each month even if you are invested in multiple funds within the Generate KiwiSaver Scheme.
4. International equities are made up of directly held equity investments.
5. 'Cash and cash equivalents' includes the value of foreign exchange hedging derivatives related to the fund's off-shore investments, on call deposits and short term (less than 12 months) fixed interest investments.
6. Listed property includes investments in aged care companies.
7. The Fund has the ability to invest in unlisted property and infrastructure investments as per limits set in the SIPO.
8. Australasian equities include an investment in unlisted New Zealand equities.
