What is the purpose of this update?

This document tells you how the Fixed Interest Managed Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Generate Investment Management Ltd prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fixed Interest Managed Fund aims to provide a stable return over the short to medium term. It invests in an actively managed portfolio made up entirely of income assets. Volatility is likely to be low to medium. Returns will vary and may be low or negative at times.

What are the risks of investing?

Risk indicator for the Fixed Interest Managed Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. 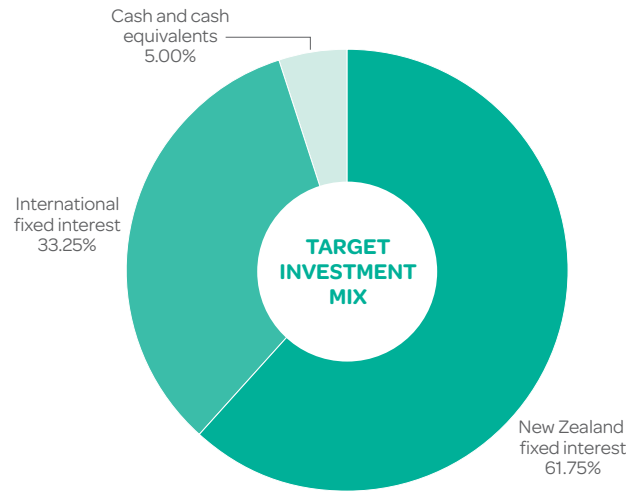
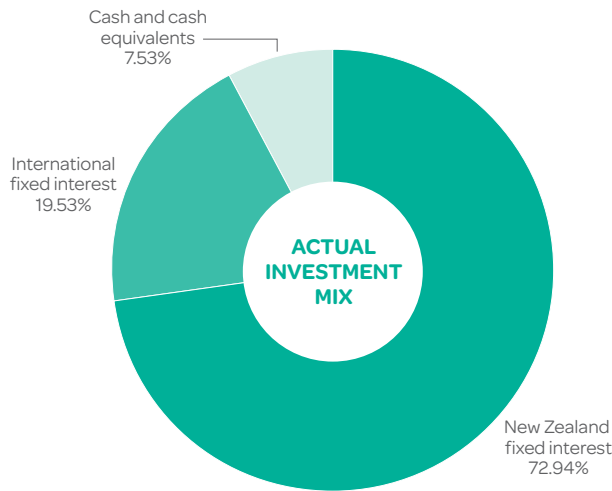
Example of how this applies to an investor

Hannah had \$10,000 in the fund at the start of the year and did not make any further contributions, and the fund generated the same gain as the market benchmark (adjusted for expected fees). At the end of the year, Hannah received a return after fund charges were deducted of \$233 (that is 2.33% of her initial \$10,000).

Notes

- As the fund has not been in existence for 5 years a combination of market index returns and the fund's actual returns has been used to complete the risk indicator. Actual returns have been used from 2 May 2025 to the end of the period to which this fund update relates. For all relevant periods prior to 2 May 2025 market index returns have been used in order to construct a total of 5 years of returns on which to base the risk indicator. As a result of estimated returns partially being used, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
- 'Cash and cash equivalents' includes the value of foreign exchange hedging derivatives related to the fund's off-shore investments, on call deposits and short term (less than 12 months) fixed interest investments.
